WHEREAS, Executive Order No. 43, Series of 2011, enjoins all department and agencies to orient their programs, projects, and activities towards the pursuit of five (5) Key Results Area that include Poverty Reduction and Empowerment of the Poor and Vulnerable;

WHEREAS, a well-thought strategy to reduce poverty incidence in the country is the implementation of Grassroots Participatory and Budgeting Process (GPBP) that aims to ensure the inclusion of the funding requirements for the development needs of the poorest municipalities and cities in the program and hudgets of National Government Agencies (NGAs);

WHEREAS, the Department of Agriculture (DA) is one of the NGA participating agencies as identified in the DBM-DILG-DSWD-NAPC JMC No. 1, Series of 2012 dated December 19, 2012, re: Guidelines for the Implementation and Monitoring of Bottom-up Budgeting (BuB) Projects in FY 2013;

WHEREAS, the DA is pursuing sustainable food production and advocacy program to guarantee establish adequate food supply and achieve higher standard of living for the Filipino people.

WHEREAS, the DA likewise aims to attain food self-reliance and self-sufficiency in the country by enhancing the capabilities of the Filipino people in the production of their own food through the adoption of various means of vegetable and other staple crop production;

WHEREAS, the livelihood projects that will be established in Quezon City are envisioned to integrate farming into the lifestyle of urban dwellers by introducing the values of basic food production, healthy food system, and clean urban environment;

WHEREAS, the DA acknowledges the capability of the Quezon City government as partner in the Local Poverty Reduction Project in the Operation and Maintenance of Farm Machineries.

WHEREAS, pursuant to Section 455 (b) (l) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bords, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.
