Liban III, amounting to Two Million Eight Hundred Twenty Four Thousand Five Hundred Pesos (Php2,824,500.00) to be charged against the available funds of the same office";*

*WHEREAS, in the said resolution, the specification of the motor vehicle appears as AUV Shuttle instead of Passenger Van, which is the true and correct specification to be procured by the said office;*


NOW, THEREFORE,


