RESOLUTION NO. SP- 6199 , S-2015

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS — NATIONAL CAPITAL REGION (NCR), IN THE IMPLEMENTATION OF THE CONSTRUCTION/IMPROVEMENT OF VISAYAS AVENUE EXTENSION (TANDANG SORA AVENUE REPUBLIC AVENUE), QUEZON CITY, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Department of Public Works and Highways is mandated and is responsible for the planning, design, construction and maintenance of infrastructure, especially the national highways, flood control and water resources development system, and other public works in accordance with the national development.

WHEREAS, Section 455 (4) of the Local Government Code of 1991 provides "Ensure the delivery of basic services and the provision of adequate facilities as provided for under Section 17 of this Code" and in addition thereto, shall:

- (i) Ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the city, and in the case of component cities, of the city and of the province; and
- (ii) and Coordinate the implementation of technical services, including public works and infrastructure programs, rendered by national offices in the case of highly urbanized and independent component cities, and provincial offices in the case of component cities.

WHEREAS, the Department of Public Works and Highways is tasked to undertake the implementation of the Construction/Improvement of Visayas Avenue Extension (TandangSora Avenue Republic Avenue), Quezon City in order that construction thereat may be started and to provide the necessary funds for the One Thousand Three Hundred Fifty Three (1,353) informal settlers/families prescribed under Republic Act No. 7279 and under the Memorandum of Agreement:

WHEREAS, the Quezon City, through the City Mayor, Herbert M. Bautista, agrees to undertake the clearing and removal of One Thousand Three Hundred Fifty Three (1,353) informal settlers/families (subject to the rules prescribed under Republic Act No. 7279) and the structures that will be affected by the Construction/Improvement of Visayas Avenue Extension (Tandang Sora Avenue – Republic Avenue), Quezon City;

WHEREAS, it is necessary that a Memorandum of Agreement be executed and entered into between Quezon City, through Mayor Herbert M. Bautista, and the Department of Public Works and Highways-NCR, through Engr. Reynaldo G. Tagudando, Regional Director, to show that the parties have accepted and mutually agreed in the terms and conditions set forth under the Memorandum of Agreement;

WHEREAS, the City Council hereby authorize the Honorable Herbert M. Bautista, City Mayor, for and in behalf of the Quezon City Government, to enter and sign a Memorandum of Agreement with the Department of Public Works and Highways.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, represented by the City Mayor, Honorable Herbert M. Bautista, to enter and sign a Memorandum of Agreement with the Department of Public Works and Highways — National Capital Region (NCR), in the implementation of the Construction/Improvement of Visayas Avenue Extension (Tandang Sora Avenue Republic Avenue), Quezon City, subject to existing laws, rules and regulations.

RESOLVED, FURTHER, that a copy of this Resolution be furnished to the National Capital Region Director of the Department of Public Works and Highways for his information and guidance.
