A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO TWA, INC. FOR THE CONSTRUCTION AND OPERATION OF A FLYING V GASOLINE FILLING STATION TO BE LOCATED AT MINDANAO AVENUE EXTENSION, NEOPOLITAN BRITANNY EXECUTIVE VILLAGE, BARANGAY PASONG PUTIK PROPER, QUEZON CITY.

WHEREAS, petitioner TWA, Inc., a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Flying V gasoline filling station located at Mindanao Avenue Extension, Neopolitan Brittany Executive Village, Barangay Pasong Putik Proper, Quezon City;

WHEREAS, fuel stations are among the uses that require Special Use Permit upon authorization from the Quezon City Council pursuant to Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000 as amended;


WHEREAS, TWA, Inc., has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a Flying V gas station will provide employment and promote economic development in the City.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to TWA, Inc. for the construction and operation of a Flying V gasoline filling station to be located at Mindanao Avenue Extension, Neopolitan Brittany Executive Village, Barangay Pasong Putik Proper, Quezon City.


