A RESOLUTION GRANTING A SPECIAL PERMIT TO THE GALLERA DE GUISON HERMANOS, INC. (LA LOMA COCKPIT) FOR THE OPERATION OF ITS BUSINESS FOR A PERIOD OF TWO (2) YEARS COVERING THE CALENDAR YEARS 2014-2016 IN ACCORDANCE WITH EXISTING LAWS, RULES AND REGULATIONS, AND SUBJECT TO THE PAYMENT OF CORRESPONDING TAXES, FEES AND OTHER CHARGES THEREFOR.

WHEREAS, Gallera de Guison Hermanos, Inc. (La Loma Cockpit) was granted a Special Permit under Resolution No. SP-4810, S-2010 for a period of four years covering 2010, 2011, 2012 and 2013;

WHEREAS, a Special Permit was granted for expansion increase in area occupied by the cockpit from 25 square meters to 1,500 square meters;

WHEREAS, the said cockpit holds five (5) derbies every year and pintakasis five days per week, this is every Tuesday, Thursday, Friday, Saturday, and Sunday or a total of two hundred forty (240) pintakasis per year:

WHEREAS, there is a need to renew the Special Permit granted by the City Council for the operation of its business;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to the Gallera de Guison Hermanos, Inc. (La Loma Cockpit) for the operation of its business for a period of two (2) years covering the calendar years 2014-2016 in accordance with existing laws, rules and regulations and subject to the payment of corresponding taxes, fees and other charges therefor.
