A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT OF USUFRUCT WITH THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) REPRESENTED BY ITS DIRECTOR GENERAL HONORABLE JOEL J. VILLANUEVA FOR THE USE OF A PARCEL OF LAND (LOT 10, BLOCK 17 LRC PSD-13293) COVERING SIX HUNDRED THIRTY SQUARE METERS (630 SQ.M.), THE SITE OF THE CENTER OF TECHNICAL EXCELLENCE FOR BIOMEDICAL EQUIPMENT SERVICING LOCATED AT DAHLIA AVENUE, BARANGAY FAIRVIEW, QUEZON CITY.

WHEREAS, the Quezon City Government is the owner of a parcel of land identified as Lot 10, Block 17 (LRC) PSD-13293 with an area of 15,636 square meters located at Dahlia Avenue, Barangay Fairview, Quezon City:

WHEREAS, the Technical Education and Skills Development Authority (TESDA) occupies Six Hundred Thirty Square Meters (630 sq. mts.) of the said parcel of land and manages within that area the TESDA-Quezon City Lingkod Bayan Skills Development Center (TESDA-QCLBSDC), a training center and the Center of Excellence for Biomedical Equipment Servicing:

WHEREAS, the Memorandum of Agreement Deed of Usufruct previously executed by the Quezon City Government and the Technical Education and Skills Development Authority (TESDA) expired last August 16, 2012;

WHEREAS, TESDA seeks the renewal of the aforementioned Memorandum of Agreement Deed of Usufruct for another period of Five (5) years to achieve and or continue its on going plans and programs.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a Contract of Usufruct with the Technical Education and Skills Development Authority (TESDA) represented by its Director General Joel J. Villanueva for the use of a parcel of land covering 630 square meters the site of the Center of Technical Excellence for Biomedical Equipment Servicing located at Dahlia Avenue, Barangay Fairview, Quezon City.
