A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM, INC. FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT NO. 1295 E. RODRIGUEZ, SR. AVENUE, BARANGAY KRISTONG HARI, QUEZON CITY.

WHEREAS, fuel stations are among the uses that require a Special Use Permit upon authorization from the Quezon City Council pursuant to Ordinance No. SP-0918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, as amended;

WHEREAS, Unioil Petroleum, Inc. has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a gas station will provide employment and promote economic development in the City.


NOW, THEREFORE,


