WHEREAS, Ernesto Rondon High School is one of the secondary public schools in Quezon City who has a big population of students which caters eight (8) barangays namely: Barangay Bagong Pag-Asa, Bahay Toro, Project 6, Talipapa, Culiat, Tandang Sora, Pasong Tamo and Sto. Cristo;

WHEREAS, there is a need to expand their school premises in preparation for the students of Senior High School's facilities, laboratories and school ground which will commence in the school year 2015-2016, and considering also that Barangay Project 6 is a fast-growing community;

WHEREAS, the adjacent lot of Ernesto Rondon High School, specifically the "Cooperative Market" should be purchased to expand the school premises of the said public school, especially so that the lot area of the school is affected by the implementation of three (3) meters easement along the Culiat River;
