A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM, INCORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT LOT 20-B, BLOCK 371, AND LOT 22-A A. BONIFACIO AVENUE, BARANGAY SAN JOSE, QUEZON CITY.

WHEREAS, petitioner Unioil Petroleum, Inc., a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline filling station located along Lot 20-B, Block 371, and Lot 22-A A. Bonifacio Avenue, Barangay San Jose, Quezon City;

WHEREAS, fuel stations are among the uses that require Special Use Permit upon authorization from the Quezon City Council pursuant to Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, as amended;

WHEREAS, Unioil Petroleum, Inc. has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a gas station will provide employment and promote economic development in the City.
