A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PILIPINAS SHELL PETROLEUM CORPORATION, FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT 214 ROOSEVELT AVENUE BARANGAY DEL MONTE, QUEZON CITY IN ACCORDANCE WITH THE COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

*WHEREAS, in accordance with the provisions of Ordinance No. SP-918, S-2000, otherwise known as "Quezon City Comprehensive Zoning Ordinance" and its Implementing Rules and Regulations, a Special Use Permit is required for this project;*

*WHEREAS, the Sangguniang Barangay of Barangay Del Monte interposes no objection to the proposed construction because of the benefits and development that would be realized out of the said project.*


NOW, THEREFORE,


