RESOLUTION NO. SP- **6226**, S-2015

*A RESOLUTION EXPRESSING THE HIGHEST FORM OF COMMENDATION TO FIFTEEN (15) OFFICERS OF THE PHILIPPINE NATIONAL POLICE SPECIAL ACTION FORCE (PNP-SAF) WHO WERE WOUNDED IN COMBAT IN MAMASAPANO, MAGUINDANAO DURING A LAW ENFORCEMENT OPERATION IN PURSUIT OF TWO INTERNATIONAL TERRORISTS ZULKIFLI "MARWAN" ABDHIR AND ABDULBASIT USMAN.*

*WHEREAS, on January 25, 2015, Sunday morning, some of the 392 PNP-SAF troopers entered the territory of the Moro Islamic Liberation Front (MILF) and its breakaway group, Bangsamoro Islamic Freedom Fighters (BIFF), to serve arrest warrants to two international terrorists, Malaysian Jemaah Islamiyah leader Zulkifli "Marwan" Abdhir and Filipino bomb maker, Abdulbasit Usman; y*

WHEREAS, the PNP-SAF's 84<sup>th</sup> Seaborne Battalion served as the assault team and successfully raided four huts in the swamps of Tukanalipao, Mamasapano, Maguindanao, killing "Marwan". While the 84<sup>th</sup> Seaborne Battalion was leaving the area of operation to meet the 55<sup>th</sup> Special Action Company, the strike team's blocking force, a firefight erupted between the latter group and armed rebel group;

WHEREAS, several grueling hours after, forty-four (44) officers of the PNP-SAF were killed and fifteen (15) were wounded in the deadly clash deemed as the biggest bloodbath in the history of PNP;


NOW, THEREFORE,


