A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO THE DIOCESE OF CUBAO FOR THE CONSTRUCTION OF A COLUMBARY WITHIN A CHURCH LOCATED AT LOURDES CASTILLO CORNER CORDILLERA STREETS, BARANGAY DON MANUEL, QUEZON CITY.

WHEREAS, petitioner Roman Catholic Archbishop of Manila, through the Diocese of Cubao, represented by Most Rev. Honesto F. Ongtioco, DD, Bishop of Cubao, is applying for the issuance of a Special Use Permit (SUP) for the construction of a columbary within the Our Lady of Fatima Parish Church located at Lourdes Castillo corner Cordillera Streets, Barangay Don Manuel, Quezon City;

WHEREAS, the Barangay Council of Barangay Don Manuel and the residents therein interpose no objection to the said project;

WHEREAS, the construction of Columbary (Cemeteries) are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Article VII, Section 2(c) of Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, as amended;

WHEREAS, the abovementioned proposed project (which shall consist of 3,000 vaults, 100 of which shall be for the poor at no cost) has complied with the requirements for the issuance of a Special Use Permit, as required by said Ordinance;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare and in keeping with the general pattern of development in the community.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to the Diocese of Cubao for the construction of a columbary within a church located at Lourdes Castillo corner Cordillera Streets, Barangay Don Manuel, Quezon City.
