A RESOLUTION GRANTING A SPECIAL PERMIT TO BPC MANAGEMENT GROUP, INC. TO OPERATE A BINGO HALL LOCATED AT NO.1 KAMIAS ROAD, QUEZON CITY, FOR PURPOSES OF HOLDING BINGO GAMES SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND CORPORATION.

WHEREAS, BPC Management Group, Inc., a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with principal office at No. 1 Kamias Road, Quezon City.

WHEREAS, Prosperity Bingo Center was an accredited Bingo Center by the Philippine Amusement and Gaming Corporation and was granted by the Quezon City Council the authority to operate a Bingo Center as per Resolution No. SP-4314, S-2008;

WHEREAS, Prosperity Bingo Center represented by Maria Cecilia P. Catapang and BPC Management Group, Inc., represented by its President, Edmundo C. Jocom, entered into a Deed of Assignment with Bingo Franchise Assets and Facilities which was executed on October 8, 2009;

WHEREAS, PAGCOR on 22 April 2014 issued the Certificate to Operate e-Bingo Boutique to BPC Management Group, Inc.;

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted BPC the authority to operate bingo hall;

WHEREAS, under the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Council, through a Resolution, may grant Special Permits or Licenses;

WHEREAS, BPC Management, Inc. through its representative Mr. Edmundo C. Jocom is applying for a special permit to operate a bingo hall in Quezon City;


WHEREAS, the authority herein granted shall be for a period of two (2) years and subject for renewal by the City Council;

WHEREAS, BPC Management Group Inc. shall remit a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.


NOW, THEREFORE,


