A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE IN THE AMOUNT OF ONE MILLION TWO HUNDRED THOUSAND PESOS (P1,200,000.00) TO BE USED FOR THE MONITORING OF PROJECTS AND PROGRAMS OF THE OFFICE OF COUNCILOR CANDY A. MEDINA OF THE 6TH DISTRICT OF QUEZON CITY, CHARGEABLE AGAINST THE FUNDS OF THE SAID OFFICE.

WHEREAS, pursuant to the provisions of the Local Government Code of 1991 and the directive of the Department of the Interior and Local Government (DILG), the city government, through the City Mayor, must be given authority by the City Council prior to the procurement of the desired motor vehicle;
