RESOLUTION NO. SP- **6234** ___, S-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE MOTOR VEHICLES INCLUDING HEAVY EQUIPMENT IN THE AMOUNT OF THREE HUNDRED FORTY MILLION THREE HUNDRED FORTY SIX THOUSAND AND TWO HUNDRED FIFTY PESOS (PHP340,346,250.00), TO BE UTILIZED BY THE DIFFERENT DEPARTMENTS OF THE QUEZON CITY GOVERNMENT, FOR THE EFFECTIVE IMPLEMENTATION, OPERATION AND MONITORING OF PROGRAMS AND PROJECTS OF THE CITY, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, Section 455 (b), (1), (vi) of R.A. No. 7160, otherwise known as the Local Government Code of 1991, states that "the City Mayor shall represent the City in all business transactions and sign in its behalf all bonds, contracts, and obligation, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, Section 455 (4) of the same Code provides that the city mayor shall "ensure the delivery of basic services and the provision of adequate facilities as provided for under Section 17 of this Code and, in addition thereto, shall:

- (i) *Ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the city, x.x.x; and*

- (ii) *Coordinate the implementation of technical services, including public works and infrastructure programs, rendered by national offices in the case of highly urbanized and independent component cities, and by national and provincial offices in the case of component cities.*

WHEREAS, the City Mayor, Honorable Herbert M Bautista, in his 2013 State of the City Address, said that "our infrastructure projects must be in synch with the aim of spreading economic gains, while balancing the social needs of development." Thus, there is a need to provide the different departments of the Quezon City Government all the needed support and equipment to attain the said purpose;

WHEREAS, a request was made by the different departments of the Quezon City Government for the procurement of motor vehicles including heavy equipment necessary for the implementation, operation, and monitoring of their respective programs and/or projects;

WHEREAS, the motor vehicles and heavy equipment requested shall have the following descriptions and shall be assigned to the following departments, to wit:




NOW, THEREFORE,


