RESOLUTION NO. SP- **6235**, S-2015

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN THE DEED OF DONATION WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY – METALS INDUSTRY RESEARCH AND DEVELOPMENT CENTER (DOST-MIRDC) FOR THE "TRASH RAKE FACILITY", HEREIN SUBJECT OF BOTH CONTRACTS, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, it is the policy of the Quezon City Government to be firmly committed to the implementation of the State principles, policies and the provision of the Philippine Constitution and the Local Government Code of 1991, "to promote and protect the people's welfare and the environment through the implementation of air pollution control measures.,";

WHEREAS, the Department Of Science And Technology - Metals Industry Research And Development Center (DOST-MIRDC) being in research and development is fabricating equipment and industrial machines, to which the "TRASH RAKE FACILITY" belongs;

WHEREAS, DOST-NCR's objective is to encourage Local Government Units (LGUs) to adopt and implement DOST technological innovations and improvements in support of the LGU programs to enhance the quality of life and well-being of the LGUs constituents;

WHEREAS, Quezon City needs technically viable technologies that will improve the living conditions of its constituents, enhance their economic and social development, and strengthen the disaster risk management systems of the city;

WHEREAS, the purpose, objectives and significance of the project to be undertaken under this agreement will contribute to the advancement of science and technology; ✓

WHEREAS, the Quezon City Government, through Mayor Herbert M. Bautista, and the DOST-MIDRC, through Roberto O. Dizon, Officer-in-Charge and Donor of the "Trash Rake facility", representing their respective agencies have agreed and signed a Memorandum of Agreement;

WHEREAS, in view hereof, there is a need to ratify the Memorandum of Agreement signed by the parties and to authorize Mayor Herbert M. Bautista in his capacity as the Mayor of Quezon City to sign the Deed of Donation in behalf of the Quezon City Government.

RESOLVED, FURTHER, to authorize, as it hereby authorizes, the Quezon City Government through Herbert M. Bautista, as Donee, in his capacity as mayor, to sign the deed of donation with metals industry research and development center as donor, for the "trash rake facility" subject to existing laws, rules and regulations."


