A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE THOUSAND PESOS (P5,000.00) PER FAMILY OF INFORMAL SETTLERS AT TANDANG SORA, BARANGAY MATANDANG BALARA AFFECTED BY THE ANGAT WATER UTILIZATION AND AQUEDUCT IMPROVEMENT PROJECT OF THE MWSS TO BE TAKEN FROM ANY AVAILABLE FUND OF THE OFFICE OF THE MAYOR IN ACCORDANCE WITH SECTION 28 OF REPUBLIC ACT NO. 7279 OR THE URBAN DEVELOPMENT AND HOUSING ACT OF 1992.

WHEREAS, several informal settler families in Tandang Sora, Barangay Matandang Balara will be affected by the ongoing Angat Water Utilization and Aqueduct Improvement project of the MWSS;

WHEREAS, the affected families, which will be relocated to an NHA Resettlement Project located some kilometers outside of Quezon City will not be provided with livelihood opportunities;

WHEREAS, while the MWSS will provide the amount of P5,000.00 to each affected family, such amount is deemed not enough for their relocation, and in order to alleviate the plight of the affected families in their economic, psychological and moral displacement, an additional Five Thousand Pesos (P5,000.00) will be a big help for every affected family in the adjustment to their new surroundings.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance in the amount of Five Thousand Pesos (P5,000.00) per family of informal settlers at Tandang Sora, Barangay Matandang Balara who are affected by the Angat Water Utilization and Aqueduct Improvement Project of the MWSS; to be taken from any available funds in the Office of the Mayor in accordance with Section 28 of Republic Act No. 7279 or the Urban Development and Housing Act of 1992.
