A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE HERBERT M. BAUTISTA, TO SIGN AND ACCEPT IN BEHALF OF THE QUEZON CITY GOVERNMENT THE DEED OF DONATION AND ACCEPTANCE OF TWO (2) ROAD LOTS AND ONE (1) ALLEY IN A RESIDENTIAL PROJECT CALLED "CENTRELLA TOWN RESIDENCES" OWNED BY METROSTAR PROPERTY HOLDINGS, INC. REPRESENTED BY ITS CHAIRPERSON, CANDIDA S. GOMEZ, LOCATED AT NO. 49 GSIS AVENUE, PROJECT 8, BARANGAY SANGANDAAN, QUEZON CITY.

WHEREAS, Metrostar Property Holdings Inc. is a domestic corporation registered under the laws of the Republic of the Philippines with office address at No. 90 A. Luna Street, San Juan City, Metro Manila;

WHEREAS, the Quezon City Government is a public corporation created pursuant to Commonwealth Act (CA) No. 502, as amended, and Republic Act No. 7160, as amended, with office at Quezon City Hall, Elliptical Road, Bărangay Central, 1100, Quezon City;

WHEREAS, Metrostar Property Holdings Inc. is the registered owner of the two (2) road lots covered by TCT Nos. 004-2010005463 and 004-201000546 and one (1) alley covered by TCT No. RT-118016 (284297) of the Registry of Deeds of Quezon City containing an area of Fifty-One (51) square meters, Three Hundred Fifteen (315) square meters and Two Hundred Seventy Eight (278) square meters, more or less respectively;

WHEREAS, Metrostar Property Holdings Inc., through a Board Resolution, authorized its Chairpeson, Candida S. Gomez, to execute and sign the Deed of Donation of the subject parcel of land in favor of the Local Government of Quezon City; >> 2

Gomez, hereby donates and conveys in favor of the donee, Quezon City Government represented by the Honorable Mayor Herbert M. Bautista, the two (2) road lots covered by TCT Nos. 004-2010005463 and 004-201000546 and one (1) alley covered by TCT No. RT-118016 (284297) of the Registry of Deeds of Quezon City Containing an area of Fifty One (51) square meters, Three Hundred Fifteen (315) square meters and Two Hundred Seventy Eight (278) square meters, more or less respectively, located at No. 49 GSIS Avenue, Project 8, Barangay Sangandaan, Quezon City;

WHFREAS, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "Unless otherwise provided in this Code, no contract maybe entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned.xxx...".
