RESOLUTION NO. SP- 6243 , S-2015

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR HERBERT M. BAUTISTA, TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS NATIONAL CAPITAL REGION (NCR) AND THE MANILA NORTH TOLLWAYS CORPORATION, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Department of Public Works and Highways (DPWH) is mandated and is responsible for the planning, design, construction and maintenance of infrastructure, especially the national highways, flood control and water resources development system, and other public works in accordance with the national development.

WHEREAS, the Manila North Tollway's Corporation's (MNTC) mission is to build and provide quality transport infrastructure and services that shall enable customers to experience the joy of safe travel, and to drive trade and commerce that stimulates our country's socio-economic growth;

WHEREAS, Section 455 (4) of R.A. No. 7160, otherwise known as the Local Government Code of 1991, local government unit shall "ensure the delivery of basic services and the provision of adequate facilities as provided for under Section 17 of this Code" and, in addition thereto, shall:

(i). Ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the city, and in the case of component cities, of the city and of the province; and

> (ii) Coordinate the implementation of technical services, including public works and infrastructure programs, rendered by national offices in the case of highly urbanized and independent component cities, and by national and provincial offices in the case of component cities.

WHEREAS, the newly created Sixth (6th) District of Quezon City, citing among others, the Gana Compound, the biggest community of Barangay Unang Sigaw, with its unique geographical location, urgently needs assistance;

WHEREAS, the pedestrians, majority of whom are students and children, are required to traverse along the busy and major route of EDSA Highway along Cloverleaf Balintawak, the only existing and accessible route from Gana Compound to A. Bonifacio Elementary School;

WHEREAS, the local government of Quezon City, through Mayor Herbert M. Bautista, the MNTC through Rodrigo E Franco, CEO and the DPWH have agreed to cooperate, for the construction and maintenance of a Footbridge (the Project) that will connect Gana Compound, Barangay Hall of Barangay Unang Sigaw, and the A. Bonifacio Elementary School which lies across the North Luzon Expressway;

WHEREAS, subject to the respective rights of the Parties to the Memorandum of Agreement, its common purpose, is "the timely construction and completion of a Pedestrian Footbridge, to provide the constituents safe and convenient pedestrian access";

WHEREAS, it is a necessity that a Memorandum of Agreement be executed and entered into between the local government of Quezon City, through Mayor Herbert M. Bautista, the MNTC through Rodrigo E Franco, CEO and the DPWII-NCR, through Engr. Reynaldo G. Tagudando, Regional Director, to show that the parties have accepted and mutually agreed on the Terms and Conditions set forth under the said Memorandum of Agreement;

WHEREAS, the City Council hereby authorizes Herbert M. Bautista, City Mayor, for and on behalf of the Quezon City Government, to enter and sign a Memorandum of Agreement with the DPWH.

Bautista, to enter and sign a Memorandum of Agreement with the Department of Public Works and Highways – National Capital Region (NCR) and the Manila North Tollways Corporation, subject to existing laws, rules and regulations

RESOLVED, FURTHER, that a copy of this Resolution be furnished to the Manila North Tollways Corporation, through Rodrigo E. Franco, CEO and the National Capital Region Director of the Department of Public Works and Highways for their information and guidance:
