A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE GRANT OF FUNDING PURPOSED TO ASSIST THE FAMILIES LIVING IN DANGER ZONES IN THEIR TRANSFER TO A SAFER HOMES AND BUILD STRONGER COMMUNITIES.

WHEREAS, Quezon City has been pre-selected as one of the beneficiaries of the project;


WHEREAS, the amount of One Hundred Million Pesos (Php100,000,000.00) shall be transferred to the City as funding purposed to assist families living in danger zones;

WHEREAS, it is necessary to authorize the City Mayor, Honorable Herbert M. Bautista, to enter into said Memorandum of Agreement with the Department of the Interior and Local Government.


NOW, THEREFORE,


