WHEREAS, during the 23rd Awarding Ceremonies for Judicial Excellence held last October 24, 2014 at the Manila Hotel, Quezon City RTC Judge, Hon. Angelene Mary W. Quimpo-Sale, was conferred the distinct honor of being named as one of the Most Outstanding Judges in the Philippines by her peers in the Legal Profession headed by Supreme Court (SC) Senior Associate Justice Antonio T. Carpio, Retired SC Associate Justice Angelina Sandoval-Gutierrez, and SC Associate Justice Diosdado M. Peralta, among others;

WHEREAS, Judge Quimpo-Sale graduated with a degree in AB Psychology from UP-Diliman in 1983 and Bachelor of Laws from the UP College of Law in 1989;

WHEREAS, Judge Quimpo-Sale certainly deserves the accolade bestowed on her owing to her stellar performance in the various positions she held both in private and government law practice, namely:

- Judge of the Metropolitan Trial Court Branch 32 (2002-2007) where she received from the Society for Judicial Excellence the Judicial Excellence Award for Outstanding Trial Judge for First Level Courts.*
- Judge of the Regional Trial Court Branch 106, a Family Court, (2007-present) where she received from the Rotary Club of Metro Sta. Mesa, Q.C. the Most Outstanding Family Court award for 2011-2012.*


