

*WHEREAS, on February 25, 2013, the City Council of Quezon City approved Resolution No. SP-5703, S-2013, entitled: "A resolution authorizing the issuance of a Certificate of Exception on the allowable number of classrooms in R-2 Zone requirements to Bestlink College of the Phils., Inc. for the construction of a four (4)-storey school building with roofdeck (thirty six (36) classrooms) located at Lot 762, Topaz corner Sapphire Streets, Barangay San Agustin, Quezon City, allowing deviation from the restrictions of the Quezon City Comprehensive Zoning Ordinance No. SP-918, S-2000, as amended;*

*WHEREAS, Bestlink College of the Philippines, Inc. needs to construct additional four (4)-storey school building with roofdeck (eighty seven (87) classrooms), multi-purpose area and basketball court to cater the growing number of students of their school;*

*WHEREAS, the Barangay Council of Barangay San Agustin and its residents interposed no objection to the said project;*

*WHEREAS, the proposed project shall not in a way constitute danger or peril thereof to the public health, safety and welfare in the area, and is in keeping with the general pattern of the development in the community; ¶*
