RESOLUTION NO. SP- 6255 , S-2015

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO CORPORATE APPAREL, INC. FOR THE CONSTRUCTION OF A FIVE-(5) STOREY COMMERCIAL BUILDING WITH ROOFDECK LOCATED AT LOT 2 BLOCK 3, AURORA BOULEVARD, CUBAO, BARANGAY MARIANA, QUEZON CITY, ALLOWING THE DEVIATION FROM PARKING REQUIREMENT AS PROVIDED FOR IN ARTICLE VI, SECTIONS 3 AND 4 OF ORDINANCE NO. SP-918, S-2000, OTHERWISE KNOWN AS THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE AS AMENDED.

WHEREAS, Corporate Apparel, Inc., represented by Engr. David W. Caw is applying for a Certificate of Exception for the construction of Five (5) Storey Commercial Building with Roofdeck located at Lot 2, Block 3, Aurora Boulevard, Barangay Mariana, Quezon City, which deviates from the parking requirement mandated by law;

WHEREAS, the subject commercial building has a limited parking space which is unique and different from other properties in the locality. Nonetheless, it will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, in accordance with the provisions of the Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulations, an Exception is required for the said commercial building.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception to Corporate Apparel, Inc. for the construction of a Five-(5) Storey Commercial Building with Roofdeck located at Lot 2, Block 3, Aurora Boulevard, Cubao, Barangay Mariana, Quezon City, allowing the deviation from parking requirement as provided for in Article VI, Sections 3 and 4 of Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance as amended.
