Introduced by Councilor PRECIOUS HIPOLITO CASTELO.



WHEREAS, former Department of Justice (DOJ) Secretary Raul M. Gonzalez died on September 7, 2014 at the age of 83 due to multiple organ failure during his confinement in National Kidney Transplant Institute;

WHEREAS, Sec. Gonzalez legally challenged the martial rule of strongman Ferdinand Marcos through several historically-significant petitions before the Supreme Court;

WHEREAS, from 1986 to 1988, he has served our country as Ombudsman, appointed by the late President Corazon Aquino after the EDSA People Power Revolution;

WHEREAS, the late DOJ Secretary Gonzalez served in the Philippine government in various capacities. He started as a Legal Assistant to the Governor of Iloilo in 1960 before serving as Senior Legal Assistant to the Mayor of Manila 1961. He was Executive Member of the Board of Censors for Motion Pictures under the Office of the President from 1963 to 1969, Senior Committee Counsel to the Committees on Labor and Immigration in the Philippine Senate, among others; f
