A RESOLUTION REQUESTING THE HONORABLE SECRETARY OF THE DEPARTMENT OF EDUCATION, BROTHER ARMIN A. LUISTRO, FSC, FOR THE CONSTRUCTION OF ADDITIONAL SCHOOL BUILDING IN PRESIDENT CORAZON C. AQUINO ELEMENTARY SCHOOL IN BARANGAY BATASAN HILLS, QUEZON CITY AND PROVIDING FUNDS THEREOF.

WHEREAS, the City Council shall urge the Department of Education for the construction of additional school building in President Corazon C. Aquino Elementary School, in Barangay Batasan Hills, Quezon City, under the Basic Education Facilities Fund (BEFF) of the Department of Education;

WHEREAS, the implementation of K+12 Basic Education Program and the rapid growth in the number of new enrollees in the said school has created a shortage of classrooms and school facilities, therefore, there is a need to provide for additional building for that purpose;

WHEREAS, education is a major investment that the government can make for the future of the people and a vital component in reducing poverty and inequality;

WHEREAS, as of October 2014, Pres. Corazon C. Aquino Elementary School has 8,533 enrollees and the proposed school building project shall be a four (4) storey, sixteen (16) classroom building for the accommodation and convenience of the students. A




NOW, THEREFORE,


