A RESOLUTION REQUESTING THE HONORABLE SECRETARY OF THE DEPARTMENT OF EDUCATION, BROTHER ARMIN A. LUISTRO, FSC, FOR THE CONSTRUCTION OF ADDITIONAL SCHOOL BUILDING IN PAYATAS B ELEMENTARY SCHOOL IN BARANGAY PAYATAS, QUEZON CITY, AND PROVIDING FUNDS THEREOF.

WHEREAS, the City Council shall urge the Department of Education for the construction of additional school building in Payatas B Annex Elementary School, in Barangay Payatas, Quezon City, under the Basic Education Facilities Fund (BEFF) of the Department of Education;

WHEREAS, the implementation of K+12 Basic Education Program and the rapid growth in the number of new enrollees in the said school has created a shortage of classrooms and school facilities, therefore, there is a need to provide for additional building for that purpose;

WHEREAS, education is a major investment that the government can make for the future of the people and a vital component in reducing poverty and inequality;

WHEREAS, as of June 2014, Payatas B Elementary School has 5,128 enrollees and the proposed school building project shall be a four (4) storey, eight (8) classroom building for the accommodation and convenience of the students.


NOW, THEREFORE,


