A RESOLUTION COMMENDING THE SOCIALIZED HOUSING FINANCE CORPORATION (SHFC) FOR INCREASING THE COMMUNITY MORTAGE PROGRAM (CMP) LOANABLE AMOUNT TO TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) FOR LAND ACQUSITION, SITE DEVELOPMENT, HOUSE CONSTRUCTION AND IMPROVEMENT.
