RESOLUTION NO. SP- **6267**, S-2015

A RESOLUTION DIRECTING THE QUEZON CITY ASSESSOR'S OFFICE TO CONDUCT A MASSIVE CAMPAIGN TO ENCOURAGE ALL REAL PROPERTY OWNERS TO UPDATE THEIR RECORDS REGARDING THEIR PRESENT ADDRESSES, TAX DECLARATIONS AND REAL PROPERTY TAX RECEIPTS, IN ORDER TO AVOID REAL PROPERTIES BEING AUCTIONED WITHOUT THEIR KNOWLEDGE.

WHEREAS, the Quezon City Government is mandated to formulate legislative measures which aim to improve and protect the welfare of its constituency;

WHEREAS, in order to avoid real properties being auctioned without the knowledge of the owners, the City Assessor's Office is duty bound to update the records of real property owners on matters relating to their present addresses, tax declarations and real property receipts.


