*Handwritten signatures and initials, including a large signature that appears to be "LB" and another that appears to be "DS".*


*WHEREAS, toward this end, the Quezon City Health Workers performed an active role in the realization of the objective of this undertaking.*

*NOW, THEREFORE,*


