A RESOLUTION REQUESTING THE HONORABLE SECRETARY OF THE DEPARTMENT OF EDUCATION, BROTHER ARMIN A. LUISTRO, FSC, FOR THE CONSTRUCTION OF ADDITIONAL SCHOOL BUILDING IN BAGONG SILANGAN ELEMENTARY SCHOOL IN BARANGAY BAGONG SILANGAN, QUEZON CITY AND PROVIDING FUNDS THEREFOR.

WHEREAS, the City Council shall urge the Department of Education for the construction of additional school building in Bagong Silangan Elementary School, in Barangay Bagong Silangan, Quezon City, under the Basic Education Facilities Fund (BEFF) of the Department of Education;

WHEREAS, the implementation of K+12 Basic Education Program and the rapid growth in the number of new enrollees in said school has created shortage of classrooms and school facilities, therefore there is a need to provide for additional building for those purposes;

WHEREAS, education is a major investment that the government can make for the future of the people, and a vital component in reducing poverty and inequality;

WHEREAS, as of June 2014, Bagong Silangan Elementary School has 9,364 enrollees and the proposed school building project shall be a four- (4) storey, eight - (8) classroom building for the accommodation and convenience of the students;
