A RESOLUTION REQUESTING THE HONORABLE SECRETARY OF THE DEPARTMENT OF EDUCATION, BROTHER ARMIN A. LUISTRO, FSC., FOR THE CONSTRUCTION OF ADDITIONAL SCHOOL BUILDING IN JUSTICE CECILIA MUÑOZ PALMA HIGH SCHOOL IN BARANGAY PAYATAS, QUEZON CITY AND PROVIDING FUNDS THEREFOR.

WHEREAS, the City Council shall urge the Department of Education for the construction of additional school building in Justice Cecilia Muñoz Palma High School, in Barangay Payatas, Quezon City, under the Basic Education Facilities Fund (BEFF) of the Department of Education;

WHEREAS, the implementation of K+12 Basic Education Program and the rapid growth in the number of new enrollees in said school has created a shortage of classrooms and school facilities, therefore there is a need to provide for additional building for those purposes;

WHEREAS, education is a major investment that the government can make for the future of the people, and a vital component in reducing poverty and inequality;

WHEREAS, the Justice Cecilia Muñoz Palma High School shall prioriuze the enrolment and acceptance of students residing in District II, Quezon City.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request the Honorable Secretary of the Department of Education, Brother Armin A. Luistro, FSC, for the construction of additional school building in Justice Cecilia Muñoz Palma High School in Barangay Payatas, Quezon City and providing funds therefor.
