WHEREAS, the City Council shall urge the Department of Education for the construction of additional school building in Doña Juana Elementary School, in Barangay Holy Spirit, Quezon City, under the Basic Education Facilities Fund (BEFF) of the Department of Education;

WHEREAS, the implementation of K+12 Basic Education Program and the rapid growth in the number of new enrollees in the said school has created a shortage of classrooms and school facilities, therefore, there is a need to provide for additional building for that purpose;

WHEREAS, education is a major investment that the government can make for the future of the people and a vital component in reducing poverty and inequality;

WHEREAS, as of June 2014, Doña Juana Elementary School has 6,882 enrollees and the proposed school building project shall be a four (4) storey, twelve (12) classroom building for the accommodation and convenience of the students.
