WHEREAS, the City Council shall urge the Department of Education for the construction of additional school building in Holy Spirit National High School in Barangay Holy Spirit, Quezon City, under the Basic Education Facilities Fund (BEFF) of the Department of Education;

WHEREAS, the implementation of K+12 Basic Education Program and the rapid growth in the number of new enrollees in said school has created a shortage of classrooms and school facilities, therefore there is a need to provide for additional building for those purposes;

WHEREAS, education is a major investment that the government can make for the future of the people, and a vital component in reducing poverty and inequality;

WHEREAS, as of June 2014, Holy Spirit National High School has 3,460 enrollees and the proposed school building project shall be two (2) units of four-(4) storey, twenty-(20) classroom buildings for the accommodation and convenience of students; y
