WHEREAS, with the high annual population growth, particularly in District II, Quezon City, which has reached as high as 4.6%, the development of new resettlement areas, and the choice of non-Quezon City residents to enroll their children in Quezon City schools, has contributed to high student per classroom ratios in this district, particularly in high school;

WHEREAS, the implementation of K+12 Basic Education Program and the rapid growth in the number of new enrollees in different schools has created a shortage of classrooms and school facilities, therefore, there is a need to provide for an additional building for those purposes;
