RESOLUTION NO. SP- 6285 , S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO THE NECESSARY CONTRACTS TO SELL WITH THE QUALIFIED BENEFICIARIES OF THE SOCIALIZED HOUSING PROJECT (DIRECT SALE SCHEME) LOCATED AT GROUP 13, AREA B, LITEX ROAD, BARANGAY PAYATAS, QUEZON CITY.

WHEREAS, the Quezon City Government is the registered owner of a parcel of land covered by Transfer Certificate of Title No. 25827 of the Registry of Deeds of Quezon City located at Group 13, Area B, Litex Road, Barangay Payatas, Quezon City;

WHEREAS, the City Council, through Resolution No. SP-2526, Series of 2004, authorized the then City Mayor, Honorable Feliciano R. Belmonte, Jr., to dispose of, convey and transfer through Direct Sale Lot 113-D-4-D (formerly Pesigan Property), with an area of Twenty Thousand (20,000) Square Meters, located at Barangay Payatas, Quezon City to qualified beneficiaries at a price of One Thousand Two Hundred Pesos (Php1,200.00) per square meter;

WHEREAS, in order to facilitate the disposition and documentation of the subject land, it is necessary to execute corresponding Contracts to Sell by and between the Quezon City Government and the qualified beneficiaries.
