A RESOLUTION DONATING TWO HUNDRED THIRTY (230) UNITS OF GARBAGE PUSH CARTS TO THE THIRTY SEVEN (37) BARANGAYS OF THE 3<sup>RD</sup> DISTRICT OF QUEZON CITY, AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAME TO, AND WITHOUT COST TO ITS RECIPIENTS.
