RESOLUTION NO. SP- **6290**, S-2015

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA AND THE BUREAU OF IMMIGRATION (BI), REPRESENTED BY COMMISSIONER SIEGFRED B. MISON, WHICH ALLOWS THE BI TO OCCUPY THE TWO HUNDRED FIFTY-FIVE SQUARE METERS AND FIFTY-FIVE SQUARE DECIMETERS (255.55) OFFICE SPACE AT THE SECOND FLOOR OF THE NEW CIVIL REGISTRY BUILDING IDENTIFIED AS CIVIC CENTER BUILDING C TO SERVE AS THE PRINCIPAL OFFICE OF BI'S STUDENT DESK.

WHEREAS, the City is the owner of a certain building to serve as the New Civil Registry Building identified as the Civic Center Building C located at the Quezon City Hall Complex;

WHEREAS, by virtue of Resolution No. SP-6066, S-2014, the City Mayor, Honorable Herbert M. Bautista, was authorized to sign a Memorandum of Agreement (MOA) with the Bureau of Immigration to allow the latter to use the two hundred fifty-five square meters and fifty-five square decimeters (255.55) office space at the Second Floor of the Civic Center Building C, Quezon City Hall Complex, Quezon City, to be exclusively used by the Bureau as its Student Desk Office, free of rent for the duration of the term;

Mison has entered into a Memorandum of Agreement last 08 September 2014, which allows the Bureau of Immigration to occupy the second floor of the new Civil Registry Building identified as Civic Center Building C to serve as the principal office of BI's Student Desk;

WHEREAS, the duly signed Memorandum of Agreement (MOA) and Resolution No. SP 6066, S-2014 shall form an integral part of this Resolution.


NOW, THEREFORE,
