A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN AND ACCEPT ON BEHALF OF THE QUEZON CITY GOVERNMENT A PRIVATE ROAD — RIGHT OF WAY AS CONTAINED IN A SUBDIVISION PLAN KNOWN AS LOT NO. 291-B (PSD-00-075469) UNDER TRANSFER CERTIFICATES OF TITLE NUMBERS N-326839, N-326840, N-326841, N-326842 AND N-326843 OF THE REGISTRY OF DEEDS OF QUEZON CITY SITUATED AT SITIO BATHALA, BARANGAY BAHAY TORO OWNED BY SITIO BATHALA, BARANGAY BAHAY TORO NEIGHBORHOOD ASSOCIATION, INCORPORATED, REPRESENTED BY ITS PRESIDENT, BENCILO M. ROSALES.

WHEREAS, the Quezon City Government is a public corporation created pursuant to Commonwealth Act No. 502 as amended and Republic Act No. 7160 as amended, with office at Quezon City Hall, Elliptical Road, Barangay Central 1100, Quezon City;

WHEREAS, Sitio Bathala, Barangay Bahay Toro Neighborhood Association, Incorporated, is the registered owner of a Private Road Right-of-Way as contained in a subdivision plan known as Lot No. 291-B (Psd-00-075469) covered under Transfer Certificate of Title Nos. N-326839 (Alley I containing an area of two hundred one (201) square meters); N-326840 (alley 2 containing an area of one hundred twelve (112) square meters); N-326841 (Alley 3 containing an area of One Hundred Sixteen (116) square meters); N-326842 (Footpath 1 containing an area of Twenty Five (25) square meters); N-326843 (Legal Easement I containing an area of One Hundred Sixty Three (163) square meters) of the Registry of Deeds of Quezon City;

WHEREAS, Sitio Bathala, Barangay Bahay Toro Neighborhood Association, Incorporated, through a resolution, authorized its President, Mr. Bencilo M. Rosales, to execute and sign the Deed of Donation of the subject portion of lots in favor of the Local Government of Quezon City;

WHEREAS, in compliance with the provisions of Presidential Decree No. 1216, the herein donor represented by its President, Mr. Bencilo M. Rosales, hereby donates and conveys in favor of the donee, Quezon City Government, represented by the Honorable Mayor Herbert M. Bautista, a private road – right-of-way as contained in a subdivision plan known as Lot No. 291-B (Psd-00-075469) covered by Transfer Certificate of Title Nos. N-326839 (Alley 1 containing an area of Two Hundred One (201) square meters); N-326840 (Alley 2 containing an area of ONE Hundred Twelve (112) square meters); N-326841 (Alley 3 containing an area of One Hundred Sixteen (116) square meters); N-326842 (Footpath 1 containing an area of Twenty Five (25) square meters); N-326843 (Legal Easement 1 containing an area of One Hundred Sixty Three (163) square meters) of the Registry of Deeds of Quezon City located at Sitio Bathala, Seminary Road, Barangay Bahay Toro, Quezon City;

WHEREAS, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "Unless otherwise provided in this Code, no contract maybe entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned xxx."
