BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to David-Basbas Gaming Enterprise to operate an Electronic Bingo Boutique at Neostar Hotel located at Block 43, Lot 24 Regalado Avenue, Barangay North Fairview, Quezon City.

RESOLVED, FURTHER, that David-Basbas Gaming Enterprise shall remit a franchise fee of three percent (3%) of the gross sales of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.

RESOLVED, FINALLY, that the authority herein granted shall be for a period of two (2) years only and maybe renewed by the City Council.
