A RESOLUTION DONATING TEN (10) UNITS OF COMPUTER SETS TO THE NINE (9) HEALTH CENTERS AND TO THE DISTRICT HEALTH OFFICE OF THE 3RD DISTRICT OF QUEZON CITY, AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAME TO ITS RECIPIENTS WITHOUT COST.


NOW, THEREFORE,
