A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO CONSTRUCT A NEW SCHOOL BUILDING AT PROJECT 6 ELEMENTARY SCHOOL, DIRECTING THE ENGINEERING DEPARTMENT TO PREPARE THE PLANS AND COST ESTIMATES, AND APPROPRIATING NECESSARY FUNDS THEREFOR.
