RESOLUTION NO. SP-629 9 ____, S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT WITH THE WINNING BIDDERS, AND/OR RATIFYING THE SAME, FOR THE PURCHASE OF AGRICULTURAL PRODUCTS, MATERIALS, SUPPLIES, EQUIPMENT, GARMENTS, AND SERVICES TO BE UTILIZED BY THE VARIOUS DEPARTMENTS AND OFFICES OF THE QUEZON CITY GOVERNMENT, FUNDED UNDER THE LUMP SUM APPROPRIATION OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the procurement or acquisition of supplies and services by local government units (LGUs) shall be made through competitive public bidding;

WHEREAS, Section 455 (b) (l) (vi) of the same Act provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf contracts or agreement upon authority of the Sangguniang Panlungsod;

WHEREAS, the Commission on Audit (COA) issued Audit Observation Memorandum 2014-11-C (2013), citing as basis the Supreme Court decision in the case of Hon. Gabriel Quisumbing vs. Hon. Gwendolyn F. Garcia (G.R. No. 175527), requiring the City Council to give prior authorization to the City Mayor before any expenses/disbursement will be charged against a budget lump sum appropriation;

WHEREAS, the Quezon City Department of Public Order and Safety (QC-DPOS) is the department primarily in charge with the implementation of R.A. No. 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010 in Quezon City;

WHEREAS, to fully implement its functions and to enhance the aforementioned Program, the QC-DPOS needs to purchase the following service and materials:
