WHEREAS, every year, Quezon City experiences numerous incidents of fire within its territory which destroys and damages houses and properties, and affects thousands of indigent families and individuals living in the city;

WHEREAS, it has been the continued policy of Quezon City government to give assistance to residents who are victims of all kinds of destructive fires in order to alleviate their suffering caused by the conflagration, as well as to enable them to get back on their feet and therefore continue to be productive citizens of the country.

WHEREAS, through a Council Resolution, the city has constantly provided financial assistance, taken from appropriation for grants, subsidies, and contributions under the annual budget of the Office of the City Mayor, or from any available funds of the city treasury, to indigent families, house owners, and renters/sharers whose residences are gutted or damaged by fire;

WHEREAS, the tedious procedure of giving monetary aid through an adopted resolution from this Council often causes delay in providing the needed assistance to fire victims, who are impoverished residents of the city;

WHEREAS, to address this concern, and to hasten the process of awarding financial help, it will be appropriate to directly authorize the mayor of our city to grant the same in accordance with amount generally given to the beneficiaries of this program.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor of Quezon City to grant financial assistance to fire victims in Quezon City.
