RESOLUTION NO. SP- 6305 , S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT OR AGREEMENT WITH THE WINNING BIDDERS/ CONTRACTORS FOR THE PROVISION OF SECURITY SERVICES UNDERTAKEN BY THE GENERAL SERVICES DEPARTMENT OF THE QUEZON CITY GOVERNMENT, PURSUANT TO THE PROVISIONS OF ORDINANCE NO. SP-2345, S-2014 OTHERWISE KNOWN AS THE CITY'S GENERAL APPROPRIATION ORDINANCE OF 2015.

WHEREAS, Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the procurement or acquisition of supplies and services by local government units (LGU's) shall be made through competitive public bidding;

WHEREAS, Section 22 (c) and 455 (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", requires the prior authorization of the City Council before the local Chief Executive can enter into a contract in behalf of the local government unit;

WHEREAS, Section 455 (b) (l) (vi) of the same Act provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf contracts or agreement upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;
