A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXEMPT ALL SENIOR CITIZENS, PERSONS WITH DISABILITIES AND THEIR CARERS FROM PAYING THE ENTRANCE FEE TWICE A WEEK IN ALL PUBLIC SWIMMING POOLS MAINTAINED BY THE CITY GOVERNMENT.

WHEREAS, the City government should encourage senior citizens, persons with disability and their carers to improve their physical activity levels not only during summer season but more importantly everyday as part of their habits;

WHEREAS, swimming is a perfect, low-impact exercise with a range of fitness benefits which if performed by the above-mentioned persons will be more beneficial to them;

WHEREAS, there are swimming pools constructed by the city government which are open to public, but these swimming pools are not free when it comes to the entrance fee;

WHEREAS, the City government can make the entrance fee free for all senior citizens, persons with disabilities and their carers provided that he/she is a constituent of Quezon City.

WHEREAS, in order to be entitled by this exemption, proof of residency, Senior Citizen Identification Card (I.D) and Person With Disability Identification Card are required to be shown.

WHEREAS, only one carer for every senior and person with disability is entitled to this exemption.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Herbert M. Bautista, to exempt all Senior Citizens, Persons with Disabilities and their Carers from paying the entrance free twice a week in all public swimming pools maintained by the city government.

RESOLVED, FURTHER, that the Office for Senior Citizen's Affairs (OSCA) shall see to it the effective implementation of this resolution.
