WHEREAS, it was a masterful showing of boxing from Congressman Manny Pacquiao as he dominated challenger Chris Algieri to retain his World Boxing Organization Welterweight Championship during the "Hungry for Glory" boxing event at the Cotai Arena inside The Venetian, Macau, China;

WHEREAS, Pacquiao showed Algieri that he belonged to a different class of boxers with a convincing unanimous decision victory with two judges scoring 119-103 and the third judge having it 120-102;
