*WHEREAS, the Asia-Pacific Stevie Awards is the first business award program that recognizes achievements in business in all 22 nations of the Asia-Pacific region. It is the newest of the Stevie Awards programs, which is widely considered to the world's premier business awards, conferring recognition for achievements in the workplace in programs such as the International Business Award for more than a decade;*

*WHEREAS, the award-giving body recognized ABS-CBN Broadcasting Corporation's business achievements in the past year, most especially its efforts in providing public service to Filipinos through "Tulong Na, Tabang Na, Tayo Na" campaign that included initiatives such as the selling of Tulong T-Shirts and the star-studded Tulong Fund Raising Concerts to help victims of typhoon Yolanda and conducting relief and rehabilitation operations for the victims of typhoon Pablo, the Zamboanga siege, and the Bohol quake;*


