RESOLUTION NO. SP- 6317 , S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE NINE (9) UNITS OF MOTOR VEHICLE AMOUNTING TO SIX MILLION FIVE HUNDRED NINETY SEVEN THOUSAND PESOS (P6,597,000.00) TO BE TAKEN FROM THE FUNDS OF COUNCILOR RODERICK M. PAULATE, TO BE DISTRIBUTED TO THE QUEZON CITY HEALTH DEPARTMENT AND TO THE FIVE (5) BARANGAYS IN DISTRICT II, QUEZON CITY.

No. 7160, otherwise known as the "Local Government Code of 1991", Sect. 455 (b) (1) (vi) states that "... the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, through the request of the Office of Councilor Roderick M. Paulate the purchase of the said motor vehicles will be distributed to the Quezon City Health Department and to the five (5) barangays of District II, Quezon City;

WHEREAS, four units (4) of the said motor vehicles will be utilized by the Quezon: City Health Department to render and extend health services in District II of this City;
