RESOLUTION NO. SP- **6319**, S-2015

*A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN THE DEED OF DONATION FOR VARIOUS FIREARMS WITH ACCESSORIES, IN FAVOR OF, AND TO BE UTILIZED BY, THE NATIONAL BUREAU OF INVESTIGATION, DEPARTMENT OF JUSTICE, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.*

*WHEREAS, the National Bureau of Investigation, by virtue of Executive Order No. 94, is mandated to help in the detection and prosecution of crimes; to acquire, collect, classify and preserve criminal identification records; and to obtain information on all matters affecting the public interest, and responsible for handling and solving major high-profile cases in the interest of the nation.*

*WHEREAS, the NBI is a government entity that is civilian in character. The territorial jurisdiction of the Bureau is national in scope and its power to investigate cases extends to all municipalities, cities and provinces of the entire Philippine Archipelago. The Bureau has investigative jurisdiction over (1) criminal cases, upon its own initiative and as public interest may require; (2) administrative and civil cases in which the government is interested whenever properly requested, such a wide mandate, the NBI needs support especially from the Local Government Units;*

*WHEREAS, Honorable Herbert M. Bautista, in his capacity as Mayor, wants to assist the NBI in carrying out its mandate by donating the herein subject firearms.*

*WHEREAS, the donation of the various firearms and its accessories would go a long way to help provide protection, inspire the entire Bureau, and assist in the maintenance of peace and administration of Justice;*

*WHEREAS, the City Council hereby authorizes the City Mayor, Honorable Herbert M. Bautista, to sign the Deed of Donation for various firearms with accessories, in favor of, and to be utilized by, the National Bureau of Investigation (NBI), subject to existing laws, rules and regulations.*

**NOW, THEREFORE,**

*BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to sign the Deed of Donation for various firearms with accessories, in favor of, and to be utilized by, the National Bureau of Investigation of the Department of Justice, subject to existing laws, rules and regulations.*

*RESOLVED, FURTHER, that a complete and detailed information of the Two Hundred (200) units of Glock 22 caliber pistol, Twenty (20) units of Taurus Caliber .40 pistols; and Twenty (20) units of Armalite Rifles, herein subject of the Deed of Donation and as submitted by the General Services Department be made an integral part hereof.*




