RESOLUTION NO. SP- **6324** , S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH BARANGAY DAMAR, REPRESENTED BY ITS PUNONG BARANGAY, ESTER M. GUTIERREZ AND DAMAR VILLAGE HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY ITS PRESIDENT, MR. JIMMY K. CHUA, FOR THE SUPERVISION, MAINTENANCE, SECURITY AND UTILIZATION OF DONATED ROADS AND OPEN SPACES OF DAMAR VILLAGE.

WHEREAS, the Quezon City Government (QCG) is a public corporation created pursuant to Commonwealth Act No. 502, with principal office at Quezon City Hall, Elliptical Road, Barangay Central, 1100 represented by its Local Chief Executive, Honorable Herbert M. Bautista;

WHEREAS, Barangay Damar of Quezon City is a local government unit of the Republic of the Philippines under the authority and supervision of Quezon City, duly represented by its Punong Barangay, Honorable Ester M. Gutierrez;

WHEREAS, Damar Village Homeowners Association Inc., is a domestic non-stock and non-profit organization duly organized and registered with Housing and Land Use Regulatory Board (HLURB) with office address at Sgt. Rivera Street (formerly Tagaytay St.) Balintawak, Quezon City, duly represented by its President, Mr. Jimmy K. Chua;

WHEREAS, on June 29, 1995, in compliance with the provisions of Presidential Decree No. 1216, the San Miguel Corporation, represented by its Senior Vice President-Comptroller, Mr. Francisco G. De Liano has donated in favor of the Quezon City Government, thirteen (13) roads and three (3) open spaces of Damar Village, Barangay Damar, Quezon City;




NOW, THEREFORE,


